In the last two decades, there has been a transition from a centralised mainframe computer environment to a distributed network for which an organisation has the ability to share computer processing. One of the fastest growing segments of the computer industry is the local area network (LAN), which is said to be the wave of the future. Coupled with this has also been the growth in cloud computing, which promotes seamless transfer and exchange of information across the globe. LANs permit the transfer of information between microcomputers, word processors, data storage devices, printers, voice devices and telecommunication devices. Current opinion holds that the flow of organisational communications has been enhanced by the transition from the optimisation of computers experienced in the traditional distributed network to the optimisation of human resources in the LAN environment. It has been further enhanced by the adoption of the use of hand-held devices that are used in cloud computing platforms.
