He agreed that he insulted and harassed his 43-year-old wife and further ordered her to have sex with him at their home in Mandlangemphisi sometime in January this year. It was gathered that the man, his wife and a team of friends was seated under a tree but were forced to move into the man's house when it began to rain.

The wife stated that when they were inside the house, her husband demanded that they have sex, which she refused. Although she refused, he kept pestering her and even insulted her for refusing. She stated that she tried to reason with him, but he was too drunk to understand. The wife was so distressed by her husband's behaviour that she went to report the matter to her parental home before reporting it to the police. She noted that it was not the first time that her husband harassed her sexually. She said that she sometimes spends the night in the bushes together with her children. When the husband is drunk he chucks them out of the house.

The husband apologised to her before the court and had already smoked a peace pipe with his in-laws before coming to court. He was convicted and sentenced to six months imprisonment with the option of a sixty emalangeni (E60) fine.
