QUESTION 1

Your school will be participating in the 2010 inter-schools' athletics competitions. You have just completed the selection process of the school team and the team is made up of forty (40) athletes: twenty (20) boys and twenty (20) girls. The competitions are held at the Mavuso Sports Complex in Manzini – fifty kilometers from your school.

PROBLEM (25 marks)

Prepare a plan for this trip to send your school team to the meeting. In the plan, discuss considerations for the selection of officials to accompany the team and their responsibilities, the welfare of the team and its officials, competition requirements for your athletes and other logistical requirements, and issues to be considered before, during and after the trip. Prepare a budget for this trip.

QUESTION 2 (25 marks)

Discuss the concept of Fair Play. In your discussion, include the relevance of rules, the concept of sporting spirit, the promotion of Fair Play by different sports participants and the basis for ethical behavior. Conclude your discussions by setting one objective for the following:

- Drug-Free Sport;
- Eliminating discrimination in sport;
- Fair and ethical practice in sport;
- Accessibility and equal opportunity in sport practice.

QUESTION 3

Your local sports committee for school teachers request that you lead the establishment of a local teachers' sports association. You are tasked to first establish the association constitutionally and are requested to table the first draft of a possible constitution at the next meeting.

PROBLEM (25 marks)

- a) Prepare a draft of the constitution. For preparing the draft constitution, use and detail on the following topics;
 - Title;
 - Objectives (not more than three objectives)
 - Membership
 - Finance;
 - The Officers;
 - The Annual General Meeting;
 - The Executive Committee;

- Conduct of Meetings; and
- Amendments to the constitution
- b) Discuss the duties of the following office bearers in an executive committee of a sports board;
 - Role of the President;
 - Role of the Secretary;
 - Role of the Treasurer;

QUESTION 4 (25 marks)

- a) Discuss the relationship between school leadership and the school's sports committee. In your discussion, give five (5) points for each of the following:
 - Why sport is important to the schools as a whole;
 - Why the school is important to the school's sports;
 - Signs of a healthy relationship between a school leadership and schools sports committee;
 - Signs of a poor relationship between a school leadership and schools sports committee;
- b) The school's sports committee, which you chair, has failed to account for the football competition's finances that you received from the school's principal. The funds were meant to cater for the school's team. This lack of accountability has led the principal to stop releasing finances for the current year's school sports programme. Use the six-step process to attempt to solve the problem.
