### **QUESTION 1**

- a) Legislation requires that an employer has to manage safety and health at work so as to prevent accidents and ill-health.
- Required safety measures must be adequate to eliminate, control or minimize the risk of injury.
- c) A hazard is something with a potential to cause harm.
- d) Measuring the risk that a hazard may pose, depends only on the likelihood of that harm occurring at the workplace.
- e) Assessing risk means examining carefully what, in the workplace, could cause harm to the employees, other people, including customers, visitors and members of the public.
- f) Carrying out risk assessments, preparing and implementing a safety statement will prevent accidents and ill health.
- g) A comprehensive safety statement, if properly implemented, is a practical tool for reducing accidents and ill health at work.
- h) Risk assessment is the determination of quantitative or qualitative value of risk related to a concrete situation.
- Risk management is a scientifically based process consisting of hazard identification, hazard characterization, exposure assessment and risk characterization.
- j) Hazard identification is the causal link between agent and effect.
- k) The risk assessment process ensures that factors influencing health are fully understood and adequately quantified so that decisions are taken inconsistently and in a cost-effective manner.
