QUESTION 2

a) Rp is a patient on the ward who has had several admissions for the treatment of cancer of the prostate. He sometimes experiences fainting spells and each time that happens he receives blood transfusions. In the course of his illness RP has become quite knowledgeable about his condition and knows that his Blood Pressure and red cells counts are important indicators of his condition. When nurse PK takes RP's blood pressure and charts it, RP asks what the reading was, nurse PK becomes annoyed and says "it was fine" and quickly leaves RP's bedside. When nurse PK returns to RP's bedside, she finds him reading his chart which had been left on his bedsides stand. Nurse PK returns to RP's bedside stand. Nurse PK patients to see their charts.

Evaluate nurse PK's actions in this scenario.

b) Mondle, a 47 year old man is admitted for severe depression following the failure of his once successful small business and divorce from his wife of 15 years. His wife and children now live in South Africa. Mondle's depression has progressed to the point where he is refusing all medications, food and water in the hope that he will die. Intravenous therapy has been instituted and he is receiving IV. His nutrition is maintained by force feeding him through a nasogastric (NG) tube. Despite the fact that Mondle is restrained he manages to dislodge the NG tube necessitatory that the NG tube be passed anew each time he is to be fed. Nurses found this procedure a real nuisance since it required additional sedation of the patient. The procedure required three or four persons to hold Mondle while the NG tube was being passed and he was fed. Because of the gripping while trying to force feed hem. Mondle developed bruise marks on his lower jaw and body. One of the nurses was concerned and reported this to the supervisor. The supervisor said the bruises were incosequential considering the necessity of nutrition being supplied to Mondle.

Evaluate the nurses actions utilizing ethical/moral justifications, if any. (10)
