QUESTION ONE (Compulsory)

THE NURSE EPIDEMIOLOGIST AND NEWBORN STATISTICS

Grace Dlamini was the community health nurse responsible for interpreting mortality and morbidity statistics for her regional health sector. Based on a preliminary listing of figures, she initiated a comparative study of newborn morbidity from the death certificates of infants delivered at two regional hospitals. The study revealed that one of the hospitals had a high rate of newborn deaths. On a closer look, the nurse found that the physicians and midwives were using a particular kind of instrument-assisted delivery. When she presented her findings to the regional health administrator, he shelved the report. She persisted and eventually went public with her findings. Despite eventual investigation into the matter and a change of the procedures at the hospital in question, Grace was labeled as "a Traitor" by officials at her region, and she lost support of nurse colleagues employed in the region. After several months of this treatment, she resigned her position.
