QUESTION 1

Read the following newspaper article. What syntactic problems do you note? (30)

A truck driver died tragically yesterday when he lost control of the truck, which then overturned several times before exploding right in the middle of the notorious Malagwane Hill, literally roasting him beyond recognition. This accident, which left scores of motorists shell-shocked, happened just before noon yesterday near Setsembiso Sebunye (Bahai) High School.

It was a chaotic scene as some impatient motorists blew their horns and demanded way.

Persons trapped in the jam included high-profile personalities such as Deputy Prime Minister Constance Simelane, Tourism Minister Thandi Shongwe, Housing and Urban Development Minister Mabili Dlamini, former Minister Titus Mlangeni, well-known accounts consultant Kobla Quashie, and Vusi Shiba of Shiba and the Travellers.

battling

The driver lost control of truck just after passing the Emafini traffic circle (Goldblatt) and it overturned and rolled several times on the road crashing into the guardrails separating the two Mbabane/Manzini lanes.

After rolling for a distance of over 100 metres, the truck, registered VNS 145 GP, came to a halt and immediately exploded into angry flames.

An eye witness, Themba Mavuso, informed the Weekend Observer that after the explosion a huge flame engulfed the entire vehicle, including the trailer.

"There is no way the driver could have survived, the flames were too big and violent," he said.

recognition

The truck, which was ferrying dairy products from Clover South Africa, was burnt beyond repairs. Police had difficulty trying to determine whether or not it was locally registered and to which company it belongs.

The dairy products, including yoghurt, milk, and juice were splashed all over the road, making it impossible for vehicles from or to Mbabane to pass.

Fire and Emergency Service personnel had a torrid time trying to retrieve the body of the driver from the wreckage.

It was around 1:30p.m. when a grinder was brought in to help. The front of the truck was cut to make way for the driver.

It was a sorry sight as the extensively charred body was retrieved from the wreckage and loaded in a police van at exactly 1:45pm. The driver's name is known but shall not be disclosed at this stage as his relatives have still not been notified.

"This is one of the worst accidents witnessed this year. At this stage it is difficult to say with certainty what happened but we suspect that the driver must have lost control of the truck and it overturned before exploding. It is a very tragic accident more so because the truck was badly burnt such that it was even difficult to see recognise which company it belongs to," Superintendent Mandla Mdluli said.

ferrying

Clover Swaziland General Manager Ronnie Egarearam said the truck was ferrying dairy products from Clover South Africa to Clover Swaziland in Matsapha.

"The truck belongs to a company called Nabats, based in Johannesburg. It was transporting our stock to Matsapha from South Africa. What has happened is very unfortunate," he said, whilst busy making frantic calls to his counterparts in South Africa.
