## JMC 348: DATA ANALYSIS AND REPORT WRITING FOR MASS COMMUNICATION RESEARCH

Answer FOUR questions, two from each section. Each question carries 25 marks.

### Section 1: Data Analysis

1. Both *quantitative* and *qualitative* data analysis entail and require certain *basic elements, activities, tools* and *skills*. **Identify** SIX of the so-called *BEATS* of data analysis, and **explain** how each of them features in this phase of research, with concrete examples.
2. In both qualitative and quantitative research, data analysis is essentially a process of refining raw or crude data towards answering the questions/hypotheses that were formulated for investigation. **Identify** and **explain** the stages and activities involved in the refinement of EITHER *qualitative* or *quantitative* data.
3. The data in Attachment 1 presents the time spent by housewives on watching television daily. Calculate the various *measures of central tendency* and two *measures of dispersion* from the data; then **present** the data in a frequency distribution table.

4. Attachment 2 is a data matrix. **Read** it carefully, and then do EITHER **A** or **B**.

**A: Frame** a research question that involves two variables; then **construct** a bivariate table that answers the question. **Explain** your table.

**B: Formulate** a hypothesis; then **name** an appropriate statistical technique you would use to test your hypothesis. **Explain** what the technique involves.

### Section 2: Report Writing

5. **Specify** and then **explain** the qualities of the following parts of a research report, **giving** examples: Title, Abstract, Problem Statement, Literature Review and Conclusion.
6. For a research problem of your choice, **write** its Methodology chapter in not less than **600 words**.
7. **Discuss** the essential differences between a *qualitative research report* and a *quantitative* research report.
8. Answer **A** or **B**.

**A:** Creswell (2005) describes six alternative forms for writing qualitative research reports. **List** FIVE of these forms and **explain** them.

**B:** A good research report has an unmistakable *storyline* that runs through it from beginning to end. **Discuss** this observation, illustrating your points, amply and clearly.
