QUESTION 1 - CASE STUDY (COMPULSORY)

Eric owns a small-holding farm with a few animals, a fish pond and maize plantations. He makes a living from his farming. The small holding lies adjacent to a national road. On a rainy and foggy night, a truck driving on the national road and carrying a load of fertiliser lost control due to the drunkenness of its driver, veered off the national road and overturned into Eric's land spilling the load of fertiliser into the fish pond on his property. As a result, the pond got contaminated and polluted. On that fateful night, Eric was not home. Upon his return the following day, he found all the fish dead and floating. Eric has approached you for legal advise. Construct a detailed legal opinion in which you address the following:

- (a) Identify at least three legal issues that arise from the facts.
- (b) State and explain the statutory law and common law rules that are applicable as regards the legal issues you have identified.
- (c) Apply those rules to the facts by developing legally supported argument(s) as to the rights and liability of each party.
- (d) Explain what penal sanctions may be faced by the truck driver/owner, and, what civil law remedies are available to Eric.
