Question 1

As a transport manager for Mavukuvuku Pty LTD, a freight company, your task is to calculate the amount to charge for shipping 1000 boxes, each weighing 20 kilograms and measuring 3 cubic metres, from Matsapha to Rustenburg, South Africa, which is a distance of 1000 Km for a return trip. The capacity of the trailer is 40,000 kilograms and 3,100 cubic metres.

Alternatively Mr Mthembu can work for Phinduvuke Bus Service as a transport manager for a fee of E40,000 a year.

- a) If the interest rate is expected to be 8% over the 4 year period, what is the maximum amount of money that Mr Mthembu should be willing to pay for the permit? Should he enter the business? [17 marks]
- b) If the initial cost outlay fell to E300, 000, would this alter his decision?
