QUESTION 5

Joe Gama was a prominent lawyer, with a thriving legal practice in Manzini. He also owned 50 head of cattle in the Mdzimba area. In July 2003, he executed a will in which he appointed Khanyi, his 18 year old daughter as his sole heir. Bonga and Vika (Gama's sons and Khanyi's brothers) got to know about the contents of the will and protested strongly. They sought the intervention of Chief Mveli - a staunch traditionalist, and the senior brother to Joe Gama. On one occasion, Chief Mveli had a lengthy conversation with Joe Gama in a bid to dissuade him from his intentions.
