- (c) Identify the special organs of the United Nations that contribute to the recognition and enforcement of human rights and briefly describe the task of each in this process. (10)

Evaluate this statement against the background of the present human rights question in Swaziland, paying special attention to the impact of the King's Proclamation to the Nation (No 12 of 1973), as well as the role of the monarchy in this regard.
- (b) With reference to the "Analysis of the Draft Swaziland Constitution" in the *Report of the International Bar Association* (2003), critically evaluate the quality of the Bill of Rights contained in the Swaziland Constitution, concentrating on inconsistencies, as well as omissions pertaining to access to public information and the right to form and join political parties.
