To compound matters, the surgeon advises that if Sipho does not receive a kidney transplant within the next three (3) months, he would certainly die.

But there are no precise donors in the country who match Sipho's profile. Distraught and yet eager to assist, you learn through the internet that there are hundreds of human kidneys for sale in India through agents. Two weeks later you are able to locate an agent who processes your "order", and the kidney is delivered by your agent to the hospital under the pretext that it was sourced in South Africa through the relevant channels. The transplant is performed and it is successful to revive Sipho who is eternally grateful for all your efforts, and leads to his full recovery.

Meanwhile, however, the whole transaction had been closely monitored by the International Police (Interpol), tasked with the duty of preventing the illegal trading in human body parts. You and Sipho are accordingly arrested two years later for violating the law, and you both engage an attorney against what you believe is an unjust and immoral law.

Referring closely to case authorities, illustrations as well as the differences and similarities between law and morals, discuss the potential liability of Sipho Zwane and yourself.
