QUESTION 1

In the year 2001 the state of Graceland gained independence from Great Britain. Like all newly independent states, the people of Graceland wanted to have a written constitution reflective of their history, and their aspirations as a nation. After thorough consultation, the people of Graceland were still not agreed about the nature and system of government they wanted for the new state. Constitutional law experts were consulted and they gave very conflicting responses. QUESTION 4

While walking down the bus rank in Manzini, Sly Max was attacked by two thugs who took his bag and disappeared into the thick crowd. A few minutes later, they returned to demand money from a shaken Sly Max. Both of them were brandishing deadly knives. Sly Max tried to run away but was overtaken and beaten viciously. He was already bleeding profusely when he wrenched himself free and attempted another escape. Once again he was overtaken and beaten viciously. At this point he saw a broken bottle lying nearby. In an attempt to ward off one of his assailants, he threw the broken bottle at the neck of the thug inflicting a fatal wound in the process. The thug died on arrival at the RFM hospital, Manzini.
