#### **QUESTION 1**

Lubawu Mbau is a final year law student from the University of Cameroon. She is on an educational exchange programme in Swaziland. She is presently writing her dissertation on the basic areas from which Swaziland's administrative law owes its existence.

She has conducted some research and has spoken to various people who each gave her differing opinions. First, she has been told that Swaziland has a dual legal system of government with one based at Ludzidzini and the other based in Mbabane - Hospital Hill. She has been told that the Ludzidzini government is stronger than the government based in Mbabane. She has also been told that the Ludzidzini government makes law (without consulting the government in Mbabane).

Further, Miss Mbau has been told that in Swaziland, the seat of governmental power is at the House of Parliament at Lobamba. Lastly, she tells you that some people say there is no specific institution or foundation from which Swazi administrative law owes its existence. This is because various institutions are empowered to develop their own administrative law, principles and legislation - to support their stance, they cited local government structures and the University of Swaziland.

Ms. Mbau finds you at the University of Swaziland and is told you are an able student of administrative law. Assist her establish and determine from where administrative law owes its existence in Swaziland. What other administrative law issues emanate from the above facts.

#### **OUESTION 4**

Mr. Do Good is astounded and approaches you for advice.
