# Question 6

She drew the cheque on Southern Bank for the amount of E20,000, payable to herself. She then expertly forged the signature of her boss, Johannes Smith, and presented it for payment at the Siteki branch of the Southern Bank.

The bank honoured the cheque by paying Maria the sum of E20,000 and debited the account of Johannes Steyn.
