She left the sister hood last year and she desires to claim the return of the money and stock on the ground that it had been obtained by undue influence.

## **OUESTION 3**

Makhubu entered into a contract with Gama whereby Gama was to rent Makhubu's premises in Manzini for three years at a rent of E1000.00 per month. Makhubu was aware that Gama intended to use the place as a brothel. Gama has had possession of the premises for six months but has not yet begun paying any rent.

Makhubu wishes to recover the premises and obtain payment of the arrears of rent.

## **OUESTION 4**

Khulani Maswati is a farmers co-operative association based in Vuvulane in the eastern part of the state of UNISWA. The association is involved in the planting of sugar cane for commercial purposes. The farmers entered into a contract with UNISWA Water Services company in terms of which the company would provide the association with irrigation water for the sugar cane fields. For the past five years the state of UNISWA has been experiencing severe drought episodes, so that the water company has been unable to provide enough water to the association resulting in damage to the fields.

Khulani Maswati intends to sue the water company. Advise them illustrating your anser with decided cases.

## **OUESTION 5**

Mabuza paid for admission to a race course. His identity was mistaken and he was ordered to leave, this because he had been involved in brawls on several occasions within the premises of the race course. The owners of the race course contend that a clause printed inconspicuously at the end of the programme entitled the stewards 'to turn away any person whose presence they do not desire'. The programme could be obtained only on payment and this was the only notice to the public.
