A protests that this fee is too high for such a short distance, but Maziya is adamant refusing to lower his fee. The time is 2.00 a.m. in the morning, it is cold and raining A cannot reach any other towing service, he is aware that if he leaves his car by the roadside he will not find it in the morning or if he finds it, all the vital parts would have been stripped off, so he agrees to Maziya's fee under protest. Maziya tows the car, when he claims his fee A refuses to pay.
