### **OUESTION 1** (COMPULSORY)

Rachel emigrated from Malawi, where she was born, and was raised in Swaziland, where she was domiciled, and eventually, married. Rachel died whilst on vacation in Zimbabwe, without leaving a will. Rachel is survived by her husband Masiko, and their two sons (Vika and Vukani). Rachel's estate on her death consisted of a house in Malawi, shares in a Namibia based company, a shopping complex in Matsapha, and cash at the Simunye branch of the First National Bank.

Keeping in mind the provisions of S68 of the Administration of Estates Act, 1902, advise the surviving relations as to their entitlement to Linda's estate.
