#### QUESTION ONE

David Ngowe is 22 years and is the son of Menzi Dlamini who is holding a high position in the Ministry of Agriculture. One evening on a Friday David went to a birthday party in his neighbour's homestead. While everyone was enjoying the party David proposed love to one Alice Nzunza a neighbor's daughter who was 17 years at the time and she agreed. Since everyone was busy enjoying the party David took Alice to a nearby old hut and they had sexual intercourse. One of the elderly people caught them on the act and raised an alarm which caught the attention of those who had attended the party. One of the party attendees Mandla Nduli hacked David twice on the head as he labelled David's act as a shame in the area. David sustained serious injuries. While the crowd was busy concentrating on David's injuries, one Phohlo Ncube who came late on the crime scene picked up a big stick and beat everyone when he saw his friend David covered with blood all over his face and during the skirmish Phohlo injured Bene Nkosi who died in hospital four days later. On the following day Menzi approached Alice's father Gome Nzunza and told him that David's act is viewed as a serious offence and if convicted he would spend several years behind bars and in the process he will lose his future as he was still pursuing his tertiary education at Ngwane College. Menzi promised to pay Alice's father Fifty thousand Emalangeni if he would not report the matter to the police and treat it as tibi tendlu. Constable 1129 detective Mwandza who is new in the police service is assigned to carry out investigations and he compiled a docket.

# QUESTION TWO.

While in the mines he met a 15 year old boy by the name of Senzo Dlodlo and he told the boy that he has a large herd of cattle at home in Eswatini. use the illegal crossings to come to Eswatini. When the boy arrived in Eswatini, he was subjected to abuse as he was made to sleep in the old hut without a door. When the boy asked for his money at the end of the month he was told that he would get it the following month. The boy was not paid for a period of six months and he could not report Mr. Dlako because he was in the country illegally. The matter was then reported to the police by one of the community caregivers. Investigations revealed that Dlako took the boy without the consent of the boy's parents.
