QUESTION 1

Munikwa entered into a contract of sale of a farm with Mathabela. In terns of clause 5 of their contract Munikwa – the seller, was entitled to rescind if the buyer failed to pay a monthly instalment on due date. When Mathabela tendered such an instalment fifteen days after due date Munikwa refused to accept it and rescinded the contract.

Was Munikwa within her rights. Discuss making reference to lex commisoria.

Nyoni has gotten a better paying job at Nhlangano and has transferred the lease of the flat to his brother Sibandze who is a student at the University of Eswatini. When Dlamini the landlord got to hear of this arrangement which was made without his consent he was not pleased? He has approached you for advise.

Using decided cases advise him making reference to cession, delegation and assignment.

QUESTION 3

Ginindza entered into a loan agreement with Eswatini Finance Corporation. The terms of the loan were that:

- 1. Eswatini Finance Corporation would have full control of Ginindza's wages.
- 2. The Finance Corporation would give Ginindza an allowance whose amount would be determined by the Finance Corporation.
- 3. Such allowance would be paid out at the discretion of the Finance corporation.
- 4. That Ginindza could not terminate the contract.

Ginindza is of the view that these terms are too onerous and is desirous of cancelling the contract.

Advise him illustrating your answer with decided cases.
