QUESTION ONE [COMPULSORY]

Bhacile Mndzebele and Nkhanyeti Mchobokazi underwent a traditional marriage, in terms of Swazi law and custom, some time in 2010. This was after Bhacile had been smeared with red ochre (libovu) at the cattle byre of the Mchobokazi's homestead, in remote rural Timphisini. There are four children born of the marriage, namely, Sivumelwane (born 6 July 2011); Khanyakwezwe (born 20 December 2013); Tsakasile (born 12 April 2015) and, Muzikanina (born 28 February 2018). The marriage was not registered with the Births, Marriages and Deaths Department. Additionally, none of the children have had their births registered. As as result, no marriage certificate, or birth certificates, have been issued.

The couple now desire to have their marriage, as well as the births of their four children, registered so as to be issued with the relevant certificates. The person who smeared the bride, Phangisile Mavimbela, is alive and available. All the children were born at the Mbabane Government Hospital.

You are to draft an affidavit to be used to persuade the Births, Marriages and Deaths Department register, and issue, the requisite marriage and birth certificates. You can be innovative with the factual story but ensure to comply with the essentials of an affidavit.
