QUESTION ONE (COMPULSORY)

Your client is Sawela Dludlu. Sawela informed you that his father has passed away. He also informs you that his father was married to two wives in terms of the customary rites of the Kingdom of Eswatini. Sewela has six siblings, all of whom are below the age of twenty-one years of age. Sawela is turning twenty-two this year, and is a full-time student at the University of Eswatini.

Sawela is concerned about how the estate of his father will be wound up, and whether the members of his family will be entitled to benefit from it as one Mr. Zuko Fakude alleges that he is entitled to claim the entirety of Sawela's father's estate. According to Mr Fakude, he and Sawela's father concluded a binding agreement, in terms of which Mr. Fakude stood to inherit all of Mr. Dludlu Senior's assets upon his death.

Write a detailed legal opinion on which law is to govern the distribution of the estate of Sawela's father. Explain what legal considerations will be taken into account in determining the appropriate law. Cite relevant case law to support your assertions.
