Question One

Brenda left her job as an electronics engineer at Siyavutsa Engineering to open her own electronics firm under the name Brenda's Corporation. Brenda's firm manufactured, sold and installed a new line of lightweight satellite dishes that could easily be mounted on almost any kind of structure and building. After a year of only marginally successful sales, Brenda ran into some unexpected difficulties. First, Siyavutsa Engineering brought suit against her for patent infringement. The litigation process was not only expensive, it was time consuming. Second, Brenda's main supplier, Tech Electronics had labour difficulties that stopped all shipments to Brenda for six (6) months. Unable to pay her personal debts or the debts of the business, Brenda turned to insolvency processes, seeking some sort of remedy.

She sought the services of Advocate Sputnik a renowned insolvency lawyer and trustee for counsel. Assume you are Advocate Sputnik, advise Brenda on:

- a) Whether Brenda could be forced into insolvency by her creditors.
- b) Whether Brenda's business could be forced to close down or she can make alternative arrangements under the law.
- c) Whether any of her property could be saved if she were forced into insolvency.

He rushes to a collision scene before an ambulance can get there, and tows a vehicle away to his storage yard. The driver, Vusi, is so distressed he signs the document put in front of him and does not read the fine print very carefully. Barry charges E2000 a day to store the vehicle in his storage yard, and refuses to release the car until payment is made by cash or bank guaranteed cheque. Barry laughs when

Vusi threatens to take him to court, because every day the storage is earning Barry E2 000.

Closely referring relevant authorities and principles in relation to secured transactions, advise Vusi in his predicament.
