# **QUESTION ONE**

Derrick, Dlodlo and Silas who are friends were approached by the girlfriend of Derrick who was a personal secretary (Gcebile) of a company called Marlboro (PTY) LTD in the Shiselweni Region. On the 20th March 2019 Gcebile told the three friends that the company was going to bank money amounting to E60, 000.00 the following day at 09.00 am. She further informed them as to how the money was to be transported and by who. The three friends then planned as to how they were going to take the money. On the following day the three friends drove to Nediso next to Nhlangano and parked there waiting for the company vehicle transporting the money. Derrick was armed with a pistol, Dlodlo was driving the getaway vehicle and Silas was carrying a pick-head for breaking the money box. Silas had been drinking beer almost the better part of the night. During the taking of the money Derrick shot one of the people who were transporting the money and the person died on the spot. The whole amount was taken. While Silas and Derrick were heading to the getaway vehicle two people came and tried to apprehend the robbers. Silas hacked one of the people on the head with the pick head and the person died on the spot. When the four met at an arranged place Dlodlo asked why the deceased were killed, Silas told him that it was due to drunkenness. The money was shared between the three friends as well as Gcebile. The four were eventually arrested and charged with Robbery and Murder.
