Question 1

why?

Question 5

the church. The incident happened in public, within earshot and full view of congregants, senior members of the church and passers-by. Dube was taken to the police station where he spent the night but was released the next morning when it transpired that Dube bears a strong resemblance to the actual perpetrator and was in fact not the perpetrator.
