#### **Question 1**

Muzi Mazibuko is a hardworking businessman aged 19 years. He lives with and takes care of his blind mother and pregnant girlfriend. One day he wakes up shivering violently and profusely sweating. His girlfriend recalling that Muzi had travelled to Lugedzemane, a malaria hotspot, two weeks before, quickly organises an ambulance to take him to SitaSive Clinic. At the Clinic he is seen by Dr. Mavaza, who has worked for a conitnuous13 hours by the time he sees Muzi. A mere 30 minutes before Muzi's arrival, Dr. Mavaza had informed the clinic administrator that he was now fatigued and needed to call it a day. The clinic administrator had urged him to work two more hours at a premium overtime rate. Excited by the prospect of making half his monthly salary in two hours, Dr. Mavaza continues working, after all its just two more hours. Upon learning that Muzi had travelled to a malaria hotspot, Dr. Mavaza immediately gives him two shots of a powerful antibiotic without taking his vitals and notwithstanding that Muzi is wearing a visible wristband signalling that he is allergic to antibiotics. He dies two hours later as a result of his allergic reaction to the antibiotics.

His family and dependants are aggrieved and want to take action. They have had rumours however to the effect that a mother and unborn child cannot do not have a cause of action in the case at hand. With the aid of decided cases, advice the family on what action they can take, against whom? And their prospects of success.

#### Question 2

Maggie and Cynthia are at Zukkie's bar enjoying their alcohol. They meet Mandla, their neighbour, from whom they request a lift home as the bar is about to close. Mandla agrees but says they should give him 30 minutes to enjoy his last few bottles. Cynthia is concerned with the fact that Mandla will be driving drunk but Maggie assures her that Mandla is a champion driver who has driven them home successfully whilst in a far worse state of intoxication than he is today. Cynthia is satisfied with that answer and gets into the car with Maggie. Just before arriving at their village, Mandla sleeps at the wheel such that his car encroaches onto the path of an oncoming lorry. A head on collision accident happens between Mandla's car and the lorry. Maggie and Cynthia suffer serious injury but survive, Mandla is not so lucky and dies and the lorry driver, who

was not wearing his seatbelt at the time of the accident, suffers head injuries he would not suffered had he been wearing his seatbelt.

The estate of the late Mandla is being sued for damages by Maggie, Cynthia and the lorry driver. They have come to you, a renowned lawyer in their town, for advise. With the aid of decided cases, fully advise them.

### **Question 5**
