SECTION (A)

Question 1 (this question is compulsory)

Detective Constable Tube and Tyre Phikela, a well-known no-nonsense criminal investigator, has been assigned to get to the bottom to a spate of robberies that have given the community of Kwaluseni many a sleepless nights. His frustrated superiors have given him strict orders to "bring to book the culprit or culprits, by hook or by crook." Together with his team they set out on this task. A tip-off they hastily follow, and which could very well be intended to deceive them, leads to the arrest of a once notorious robber who has done time in jail, and gotten rehabilitated/reformed. During his interrogation, he brings it to the attention of the police officers that he could not possibly have carried out the robbery on account of the fact that he has learned his lesson and that, even before the particular day the alleged robbery was carried out, he had been hospitalized for fractures on both legs: for which he was in a cast (Plaster of Paris).

Despite this explanation, Detective Constable Tube and Tyre Phikela is not satisfied and accuses him of "turning back to his old ways" and frustrating their policing campaign at reducing crime. He then suggested to his teammates that they should administer to the suspect the combined notorious "chicken" and "tube" methods to the suspect until he tells the truth.

Discuss which human right strands to be violated, were this type of interrogation to go ahead. In your discussion, indicate whether it can ever be justified and, assuming you were Detective Constable Tube and Tyre Phikela, how would you go about the interrogation.

Question 5
